



On Line Access - Terms of Use

On Line access to your loan facility (*internet access*) is available upon the following terms and conditions:

- (a) *Internet access* can be granted or terminated by us at any time.
- (b) If you have *internet access*:
 - (i) you must comply with the terms and conditions of *internet access*;
 - (ii) unless you advise the *internet access service provider* that your *access codes* have been misused, lost or stolen or the security of your *access codes* has been breached the *internet access service provider* shall be entitled to allow *internet access*. You must make every effort to ensure that your *access codes* are not lost, misused or stolen or that the security of your *access codes* is not otherwise compromised;
 - (iii) you must sign off/log off *internet access* before leaving your computer or other device unattended and advise the *internet access service provider* if one of your representatives, advisors, consultants or nominees cease to be employed by you;
 - (iv) you agree to comply with all laws and regulations governing *internet access*;
 - (v) you agree to comply with the terms and conditions of the *internet access service provider*; and
 - (vi) you indemnify the *lender* and us against loss or damage we may incur as a result of breach of these terms of *internet access*.
- (c) We make no warranty as to the accuracy of the information available via *internet access* and shall not be liable for loss or damage arising from reliance upon information made available via *internet access*.
- (d) In this letter terms in *italics* have the following meanings:
 - (i) *access codes* means user ids, usernames, passwords or other information used to access your loan statements online.
 - (ii) *internet access service provider* means any external organisation facilitating *internet access* on our behalf.
 - (iii) *lender* means BNY Trust Company of Australia Limited ACN 050 294 052 and/or Think Tank Group Pty Ltd ACN 117 819 084

If you wish to have *internet access*, you will need to complete an application form. Completion and submission of an application form will confirm your acceptance of these terms.
