1	Product features & Target market description	<b>Key Features</b> <ul style="list-style-type: none"> <li>• Loan of more than 15 years and up to 30 years in duration.</li> <li>• Loan secured against one or more commercial properties.</li> <li>• Can be used for purchase, refinance or equity take out of commercial property.</li> <li>• Minimum loan amount is \$100,000. Maximum loan amount is \$4,000,000 for a loan secured by a single property or \$5,000,000 group exposure for loans secured by two or more properties. The maximum amount of the loan is further limited by the location and serviceability assessment.</li> <li>• Minimum property value is \$200,000.</li> <li>• The amount of the loan will also depend on the loan-to-value ratio.</li> </ul>	<b>Description of the retail class that comprises the target market</b> Customers (real persons, trusts and companies) seeking a 15 – 30 year loan for the finance of a commercial owner-occupied or investment property in an urban location amortising over time where the customer can provide security over one or more commercial properties and can afford to repay the loan (suitability assessment).
		<b>Variant/ Optional features</b> <ul style="list-style-type: none"> <li>• Loans may be variable or fixed rate for up to 5 years.</li> <li>• Loans may be split between fixed and variable interest, up to four ways – minimum is \$50,000 per split (however, lower amounts may be available at sole discretion of Think Tank).</li> </ul>	Customers who want the flexibility to set their upfront fee and repayment arrangements

		<ul style="list-style-type: none"> <li>Customer has the option to enter into the loan as a Line of Credit facility, or to enter into a zero upfront fee option (see below).</li> </ul>	
		<p><b>Variable Loans</b></p> <ul style="list-style-type: none"> <li>Repayment frequency is monthly. Lump sum payments ahead of schedule are permissible.</li> <li>Redraw is permitted on variable loans.</li> </ul>	<p>For a Commercial Property Loan with a <b>variable interest rate</b> customers who:</p> <ul style="list-style-type: none"> <li>are comfortable with the risk that their interest rate and repayments may go up or down over the life of the loan as with market interest rate fluctuations and who may want flexibility to repay early without fees.</li> <li>customers who may need to prepay the loan.</li> </ul>
		<p><b>Fixed Rate Loans</b></p> <ul style="list-style-type: none"> <li>Repayment frequency is monthly. Lump sum payments ahead of schedule are permissible, subject to payment of a fee in some cases for prepayment on fixed rate loans.</li> <li>Redraw is permitted on fixed rate loans (subject to a new fixed rate).</li> <li>Principal reductions up to \$50,000 per year (in addition to scheduled repayments) permitted without an Early Repayment Fee</li> </ul>	<p>For a Commercial Property Loan with a <b>fixed interest rate</b> customers who:</p> <ul style="list-style-type: none"> <li>are comfortable locking in a fixed rate of interest or want to achieve certainty around repayments for a set period of time (up to five years).</li> <li>do not require flexibility in early repayments greater than \$50,000 or paying out the loan during the fixed interest period (without incurring an additional fee).</li> </ul>
		<p><b>Interest Only / Principal + Interest</b></p> <ul style="list-style-type: none"> <li>An interest only period of up to 5 years may be requested for investment loans, with the loan then converting to principal + interest</li> </ul>	<p>For a Commercial Property Loan with <b>interest only repayments</b> customers who:</p> <ul style="list-style-type: none"> <li>want to repay interest only for a fixed period (up to 5 years) and are prepared to pay a higher rate of interest for this feature.</li> <li>want to minimise their repayments over the interest-only period and who can make the higher payments after the interest only period to repay by maturity</li> </ul> <p>For a Commercial Property Loan with <b>principal and interest repayments</b> customers who want to repay both the principal and interest over the period of the loan.</p>

		<p><b>Line of Credit</b></p> <ul style="list-style-type: none"> <li>The loan can be established as a line of credit facility</li> </ul>	<p>For a Commercial Property Loan which is a <b>Line of Credit</b>, customers who:</p> <ul style="list-style-type: none"> <li>want the flexibility to redraw the facility on demand; and</li> <li>are comfortable paying a higher interest rate.</li> </ul>
2	<p><b>Description of distribution conditions and restrictions</b></p>	<p><b>Distribution Conditions</b></p> <p>Loans are not distributed by the Issuer directly, and are only distributed via Think Tank Group Pty Ltd (“<b>Think Tank</b>”) as representative through the following third parties:</p> <ul style="list-style-type: none"> <li>Brokers</li> <li>Aggregators representing individual brokers</li> <li>Aggregators who have entered into a White Label agreement with Think Tank allowing the Aggregator to distribute the Issuer’s products.</li> </ul> <p>(together, the “<b>Distributors</b>”).</p> <p>These distribution conditions are appropriate because they are documented agreements with the relevant parties (“<b>Distributor Agreements</b>”) which include provisions that:</p> <ul style="list-style-type: none"> <li>Think Tank may accept or reject an Application at its absolute discretion</li> <li>The Introducer agrees to comply with the Introducer Service Procedures and to use reasonable endeavours to ensure that members comply with the Introducer Service Procedures. The Introducer Service Procedures are procedures that Think Tank requires the Introducer and its members to follow as agreed in writing between the parties from time to time</li> <li>The Introducer must advise Members of any reasonable training requirements specified by Think Tank from time to time</li> <li>Think Tank reserves the right to accredit each Member in accordance with its specified accreditation process. Think Tank may refuse to accept Applications from any members that have not been accredited in accordance with its required accreditation process.</li> </ul>

This includes:</p> <ul style="list-style-type: none"> <li>Internal decisions to amend or modify the product, its features and/or its distribution</li> <li>Any regulatory changes, including court decisions, AFCA determinations and regulatory guidance</li> <li>Changes to economic conditions</li> <li>An unexpected volume of loans in arrears</li> </ul>	

		<ul style="list-style-type: none"> <li>• Significant change in customer complaints and/or feedback relating to the product.</li> <li>• An unexpected, significant increase in early termination of the product.</li> <li>• For fixed interest rate loans specifically: <ul style="list-style-type: none"> <li>- a significant increase in customers being charged early repayment and/or pay out costs</li> <li>- a change in the interest rate environment such that there is no reasonable likelihood of benefit or value to the customer of obtaining a fixed interest rate</li> </ul> </li> <li>• Any other event that occurs or information received that reasonably suggests the determination is no longer appropriate.</li> </ul>
